### **INFORMED CONSENT/RELEASE OF LIABILITY**

Your child is going to participate in the Maple Grove Farm camp program, which involves both outdoor and indoor activities. We are requesting that the parent/guardian of all minor campers sign this Informed Consent/Release of Liability Form.

I, \_\_\_\_\_, the undersigned, as parent/guardian of \_\_\_\_\_ (the "Camper(s)"), agree that the Camper is to participate in the Maple Grove Farm camp program which includes indoor and outdoor activities. I acknowledge that I have been advised that the Camper can decline to participate in all of, or any part of, the activities occurring during camp if the Camper or the Camper's Parent/Guardian wishes. On behalf of the Camper, as the Camper's parent/guardian, I hereby hold harmless, release and indemnify Maple Grove Farm, its owners, agents, employees and its contractors from any and all liability arising from the Camper's participation in any activities associated with the Maple Grove Farm camp program. I give consent for Maple Grove Farm to use any pictures, of the Camper participating in camp activities, at the discretion of Maple Grove Farm, for advertising purposes. If the Camper or the Parent/Guardian of the Camper has any questions or concerns about specific camp activities, the camp schedule, or any other issues it is the responsibility of such parties to inquire about their questions or concerns.

I, the undersigned, also give consent for the Camper to receive medical treatment in case of an emergency, during the Covid-19 outbreak. I understand that based on what is currently known about Covid-19, the spread is thought to occur mostly from person-to-person via respiratory droplets among close contact. I understand that close contact can occur from being within approximately 6 feet of someone with Covid-19 for a prolonged period of time or by having direct contact with infectious secretions from someone with Covid-19. I understand that carriers of Covid-19 may not show symptoms but may still be highly contagious. I understand that due to the unknowns of this virus and the nature of the activities here, that the Camper has an increased risk of contracting the virus.

I understand that the symptoms listed below are representative of Covid-19: Fever, Dry Cough, Shortness of Breath, Temperature, Persistent pain or pressure in the chest, and Bluish lips or face. I confirm that the camper, at the time of 2022 camp attendance does not display or currently have any of the symptoms that are representative of Covid-19, which are outlines above. I confirm that to the best of my knowledge, that the camper has not had close contact with an individual diagnosed with Covid-19 within 14 days of 2022 camp attendance. I will notify Maple Grove Farm of any changes.

I have read this Informed Consent/Release of Liability and understand its terms. I further represent that I am the parent/ guardian of the Camper and have the requisite authority to execute this document on behalf of the Camper.
